NOTICE TO USER: This control product is to be used only in accordance with the directions on this label. It is an offence under the Pest Control Products Act to use a control product under unsafe conditions.

NATURE OF RESTRICTION: This product is to be stored or displayed separately from food or feed.

RESTRICTED USES: Birlane Insecticide 25% wettable powder contains 25 kilograms of Birlane insecticide (formerly known as Compound 4072) per 100 kilograms of product. Use this product for recommended purposes and at recommended dosages.

CROP AND INSECT: Cole Crops (cabbage, cauliflower, Brussels Sprouts, broccoli) Cabbage maggot.

PRECAUTIONS: Keep out of reach of children. Keep in original container during storage. Destroy empty container. Handle and apply only as recommended and at recommended rates. Do not apply or allow to drift to areas occupied by unprotected humans or animals. Do not contaminate or store with feed or foodstuffs. Do not contaminate streams, lakes, ponds, irrigation water, water used by livestock, or water used for domestic purposes.

DANGER: Birlane insecticide is poisonous if swallowed, inhaled or absorbed through the skin. Repeated inhalation or skin contact with this or other organic phosphates may, without symptoms, progressively increase the likelihood of poisoning.

REQUIRED USER PROTECTION: Wear clean neoprene gloves and clean, waterproof protective clothing. Replace gloves frequently and destroy used gloves to prevent re-use. Wear respirator and canister effective against organophosphate vapours. Wash thoroughly with soap and water after handling and before eating or smoking.

SYMPTOMS OF POISONING: The symptoms of poisoning include weakness, headache, tightness in chest, blurred vision, non-reactive pinpoint pupils, salivation, sweating, vomiting, diarrhea and abdominal cramps.

FIRST AID:

IF SWALLOWED: induce vomiting immediately if patient is conscious. This may be done by introducing a finger into the throat. NEVER GIVE ANYTHING BY MOUTH TO AN UNCONSCIOUS PERSON. Keep patient prone and quiet. Transport the patient immediately to the nearest physician.

SKIN CONTACT: If spilled on the skin, remove all contaminated clothing at once. Thoroughly wash skin with soap and water. Contact physician. Wash contaminated clothing before reuse.

FOR EYES: If the material gets into the eyes, flush immediately with running water for at least 15 minutes. Contact physician.

TOXICOLOGICAL INFORMATION: Atropine is the specific therapeutic antagonist of choice against parasympathetic nervous stimulation. Morphine is contraindicated. Clear chest by postural drainage. Observe patient continuously for 48 hours.

APPLICATION PROCEDURE: Ontario and Quebec - Transplant water treatment. Mix 1.25 kg of Birlane insecticide 25% W.P. in 1000 litres of water. Apply 170 mL of this solution per plant. For British Columbia use the granular and emulsifiable concentrate formulations. Refer to the label directions for Birlane

insecticide 10% granules and Birlane insecticide 40 E.C. For Newfoundland use the emulsifiable concentrate formulation. Refer to the label directions for Birlane insecticide 40 E.C. For the Maritimes use the granular formulation. Refer to the label instructions for Birlane insecticide 10% granules.

APPLICATION RATE: 5 kg of Birlane insecticide 25% W.P. in 3600 litres of water per hectare.

NOTE: Do not use in combination with starter fertilizers.

DISPOSAL:

1. Thoroughly empty contents of bag into application device.
2. Make the empty bag unsuitable for further use.
3. Dispose of the bag in accordance with provincial requirements.
4. For information on the disposal of unused, unwanted product, and the cleanup of spills, contact the regional office of Conservation and Protection, Environment Canada.
