DIRECTIONS:

Shake well before using. Wet animal's head with water to drive pests onto the body. Remove cap. Hold can in an upright position about 25-30 cm from pet. Apply Beaphar Insecticidal Spray evenly to lightly dampen coat, beginning at head and working towards tail, while protecting animal's eyes from spray. For best results, pay special attention to neck and hindquarters. Ruffle long hair for better penetration of spray. Comb and brush into coat. Do not soak animal. Do not treat animal more than once a week. Ticks are difficult to control and must be sprayed

directly. May be used on pet bedding weekly. Spray infested areas paying particular attention to places where fleas and their larvae may be found.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Do not spray in eyes, on face, or on scrotum of pet. Discontinue use if dermal or nasal irritation develop. Do not use on sick animals. Do not use on animals under drug or pesticide treatment. Consult your veterinarian before use on pregnant animals. Do not use on animals under 8 weeks of age. Do not use on nursing females. Do not use near birds, fish, feed or foodstuffs. Avoid inhalation of spray. Wash hands after use. Contents under pressure. Do not spray near open flame or spark, or while smoking. Do not place in hot water or near radiators, stoves or other source of heat. Do not puncture or incinerate container or store at temperatures over 50°C.

DISPOSAL:

When container is empty, press valve to release all pressure. Then wrap, and dispose of empty container with household garbage.

FIRST AID:

If sprayed in eyes flush with clean water. If on skin wash thoroughly with soap and water. If irritation persists, obtain medical attention. If accidentally ingested obtain medical attention at once.
