Bacteria Control: Initial dose: 20-120 mL per 1,000 L of water in total system. Maintenance dose: every 1-5 days or as needed
6.4-40 mL per 1,000 L of water in system. For bacteria control, in industrial water supply systems, treat with 6.4-40 mL per 1,000 L of water entering system. NOTE: Product should not be

used in water intended for drinking or food preparation.
