Do not apply to synthetic fabrics such as acetate, rayon or spandex. Will not damage cotton, wool and nylon. May damage furniture finishes, leather, plastics painted and varnished surfaces including watch crystals, guns bows and automobiles.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Do not use on children under 12 years of age. Avoid contact with eyes and mouth. Do not apply over cuts, wounds or sunburned skin. Use of this product may cause skin irritation in rare cases. After returning indoors, wash treated skin and clothing with soap and water.
