USE DIRECTIONS

A proven "one-step" cleaner - disinfectant - sanitizer - fungicide - mildewstat - virucide in the presence of moderate amounts of organic soil. Apply to walls, floors and other hard, non-porous surfaces such as tables, chairs, countertops, sinks and bedframes, with a cloth, mop so as to thoroughly wet surfaces. For heavily soiled areas, a preliminary cleaning is required. Prepare a fresh solution daily or when used solution becomes visibly dirty.

HOSPITAL SANITIZER: Use 1:165 or 6 mL per Litre of water. Effective against a broad spectrum of gram negative and gram positive organisms as presented by: *Pseudomonas aeruginosa*, *Staphylococcus aureus*, *Salmonella cholera-esuis*, *Escherichia coli*, *Serratia marcescens*, *Klebsiella pneumoniae*, *Enterodysenteriae*, *Brevibacterium ammoniagenes*.

DISINFECTION: To disinfect hard, non-porous surfaces, treated surfaces must remain wet for 10 minutes.

FOR SCHOOLS, NON MEDICAL, INSTITUTIONAL AND INDUSTRIAL USES: Use 1:63 or 16 mL per Litre of water. Delivers excellent cleaning and germicidal effectiveness. It is effective against *Staphylococcus aureus*, *Salmonella cholera-esuis* and *Escherichia coli*, and an effective fungicide against *Trichophyton mentagrophytes* (the athlete's foot fungus) when used on surfaces in areas such as locker rooms, dressing rooms, shower and bath areas, exercise facilities etc.

VIRUCIDAL PERFORMANCE: Effective against the following viruses: Influenza A/Brazil, Herpes Simplex and Vaccinia, on inanimate environmental surfaces.
