For spills, wear appropriate safety equipment. Absorb spilled product with inert substance, such as sawdust, or sand and dispose of by burying at least 45 cm deep in a non-crop non-graze area away from water supplies.

Rinse the emptied container thoroughly and add the rinsings to the spray mixture in the tank.

Make the empty container unsuitable for further use.

Dispose of the container in accordance with provincial requirements.
