A quick penetrating, fast drying solution for protecting wood against rot, mold, mildew and water damage. To be applied to wood for above ground use. Will not evaporate or wash cut. Safe for exterior use where a natural wood finish is desired. Can be used on greenhouse and garden timber but allow to dry completely before putting in contact with plants. "Once Over" wood preservative dries to form a water repellent barrier that causes water to bead and run off. NO PAINTING NECESSARY. If in future a painted finish is desired, use oil-based paints.

DIRECTIONS: STIR WELL BEFORE USING. No thinning necessary. Surface to be treated, must be dry and clean. Remove all paint, varnish, wax or other coating that could impede penetration. Apply as much solution as will readily soak in. One liberal coat is usually sufficient. Apply by brushing or immersing object for 3 minutes per 2 centimetres of thickness. 1 litre treats 15 sq.

metres of rough lumber, 20 sq. metres of finished lumber. For better results, do not apply during periods of high humidity or under extreme weather conditions. Clean brushes or rollers with Recochem's Recordsol Paint Thinner or Turpentine.

USE LIMITATIONS: For exterior use only. Do not apply where preservative may become a component of food, feed or drinking water. Do not apply to rubber based fabric. Do not apply to fabrics where prolonged skin contact may occur.
