# DIRECTION FOR USE

Pulp and Paper: Chimtox 480 is recommended for the control of bacterial and fungal slime in the production of paper.

**POINT OF ADDITION:** Chimtox 480 should be added at a point in the system to insure uniform mixing such as the Beater, Hydropulper or Fan or Broke Storage Pump.

**DOSAGE:** Apply 88 to 400 ml of Chimtox 480 as supplied per tonne (dry basis) of pulp or paper produced, as a slug dose. If needed, repeat daily. Badly fouled systems should be cleaned before initial treatment.

## FIRST AID

IF ABSORBED: Do not induce vomiting. Drink promptly a large quantity of milk, egg whites, gelatin solution or if these are not available, drink large quantities of water. Avoid alcohol. Call a physician immediately.
