FIRST AID AND TOXICOLOGY:

Contains pentachlorophenol in petroleum distillates. If swallowed, do not induce vomiting, call a doctor. In case of spattering in eyes, wash for 5 minutes with water and call a doctor. In case of contact with skin, wash immediately with water and soap.

DESCRIPTION: A copper naphthenate based wood preservative. Recommended for exterior construction wood and wood in contact with soil.

DIRECTIONS FOR USE: The wood should be clean, dry, free of paint, varnish, grease or oil. Apply with a brush or roller. Two coats are recommended. Let dry at least 24 hours before painting over the preservative. Clean the working tools with MF

solvent #450. Covers from 6 to 8 square meters per litre depending on wood porosity. DO NOT APPLY BY SPRAY METHODS.

PRECAUTIONS: May be harmful or fatal if swallowed, inhaled or absorbed through the skin. Causes skin and eye irritation. Avoid contact with skin, clothing and eyes. Avoid breathing vapors or mist. Use only under well ventilated conditions. Wear impermeable clothing and footwear and synthetic rubber gloves when handling concentrate or freshly treated wood and during treatment. Wear eye goggles or face shield when applying. Toxic to fish, plants life and animals. Do not apply where the preservative may become a component of food, feed or drinking water. Close container when not in use. Keep away from heat, open flame and sparks. DO NOT STORE IN DWELLING. Do not burn treated wood waste in domestic stoves or fireplaces.

DISPOSAL:

- 1. Rinse the emptied container thoroughly and add the rinsings to the treatment site.
- 2. Follow provincial instructions for any required additional cleaning of the container prior to its disposal or reconditioning.
- 3. Dispose of the container in accordance with provincial requirements.
- 4. For information on the disposal of unused, unwanted product and the cleanup of spills, contact the regional office of Environmental Protection Service, Environment Canada.
- 5. For small spills. Recover free liquid. Soak up residue with solids absorbent. DO NOT FLUSH INTO SURFACE STREAMS. INFORM ENVIRONMENT CANADA AS IN #4.
