Do Not Get In Eyes, On Skin, Or On Clothing. Wear Body Covering Clothing, Impervious Gloves and Chemical Worker's Goggles When Handling This Product. #### FIRST AID TREATMENT:

IF SWALLOWED: Do not induce vomiting. Call physician and/or transport to emergency facility immediately.

IF IN EYES: Irrigate immediately with water for at least 15 minutes.

IF ON SKIN: Immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Call a physician if irritation persists. Wash clothing before reuse. Destroy contaminated shoes. Avoid prolonged or repeated contact with skin. Wash thoroughly after handling.

IF INHALED: Remove to fresh air if effects occur. Consult a physician.

#### NOTE TO PHYSICIAN:

The decision of whether to induce vomiting or not should be made by an attending physician. If lavage is performed, suggest endotracheal and/or esophageal control. Danger from lung aspiration must be weighed against toxicity when considering emptying the stomach. Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. If exposed, plasma and red blood cell cholinesterase tests may indicate degree of exposure (baseline data are useful). Atropine, only by injection, is the preferable antidote. Oximes, such as Pralidoxime Chloride, may be therapeutic if used early; however, use only in conjunction with atropine. In case of severe acute poisoning, use antidotes immediately after establishing an open airway and respiration.

#### DIRECTIONS FOR USE

DURSBAN 6 insecticidal concentrate may be used only in the manufacturing of an insecticide which is registered under the Pest Control Products Act. Because of their properties and intended uses, formulations containing DURSBAN 6 insecticidal concentrate may require precautionary labelling differing from that given. Formulators should develop their own use and

precautionary labelling based on the properties and intended uses of their own finished formulations, and in accordance with all pertinent laws and regulations.

PHYSICAL OR CHEMICAL HAZARDS: COMBUSTIBLE. Do not use or store near heat or open flame. Do not cut or weld container.

ENVIRONMENTAL HAZARDS: This product is toxic to fish, crustaceans and birds. Do not contaminate water by cleaning of equipment or disposal of wastes.
