DIRECTIONS

To kill flying insects (mosquitoes, flies, biting midge, drosophila, wasps):

Close doors and windows. Shut off all ventilating systems. Prevent persons and animals from entering area. Using a fogger or pressurized sprayer, direct mist upwards to all parts of the room especially windows and other light sources. Apply at a rate of 2 to 3 seconds per 10 m3. Whenever possible, keep doors and windows closed for 10-15 min. after each treatment. Also direct mist into areas where insects are present. Keep spray at least 1 m from interior walls, fabrics and furniture. Do not remain in treated areas. Ventilate for 1 hour before reentry. Sweep up and destroy dead insects.

To kill crawling insects (cockroaches, silverfish, spiders, ants):
Spray hiding places such as baseboards, moist areas, openings around sinks, drains and pipes, behind cabinets and storage areas. Spray ant trails around door sills, window frames or in ant nests.

Insects must be contacted to be killed. Ensure proper ventilation after sealed areas have been treated. Sweep up and destroy dead insects.

Food Processing Plants and Food Service Establishments: In food processing plants and food service establishments, apply only when plant is not in operation. Remove all food before treatment. Cover all food processing surfaces and clean them thoroughly with potable water before resuming operation.
