USE DIRECTIONS

A proven "one-step" cleaner-disinfectant-sanitizer-fungicide-mildewstat-virucide in the presence of moderate amounts of organic soil.

Apply to walls, floors and other hard, non-porous surfaces such as tables, chairs, countertops, sinks and bedframes with a cloth, mop so as to thoroughly wet surfaces. For heavily soiled areas, a preliminary cleaning is required. Prepare a fresh solution daily or when used solution becomes visibly dirty.

HOSPITAL SANITIZER: Use 1:83 or 12 mL per Litre of water. Effective against a broad spectrum of gram negative and gram positive organisms as presented by: Pseudomonas aeruginosa, Staphylococcus aureus, Salmonella choleraesuis, Escherichia coli, Serratia marcescens, Klebsiella pneumoniae, Enterobacter aerogenes, Salmonella schottmuelleri, Streptococcus faecalis, Shigella dysenteriae, Brevibacterium ammoniagenes.

DISINFECTION: To disinfect hard, non-porous surfaces, treated surfaces must remain wet for 10 minutes.

FOR SCHOOLS, NON-MEDICAL INDUSTRIAL AND INSTITUTIONAL USES: Use 1:30 or 32 mL per Litre of water. Delivers excellent cleaning and germicidal effectiveness. It is effective against Staphylococcus aureus, Salmonella choleraesuis and Escherichia coli, and an effective fungicide against Trichophyton mentagrophytes (the athlete's foot fungus) when used on surfaces in areas such as locker rooms, dressing rooms, shower and bath areas, exercise facilities etc.

VIRUCIDAL PERFORMANCE: Effective against the following viruses: Influenza A/Brazil, Herpes Simplex and Vaccinia, on inanimate environmental surfaces.
