RC DÉMOUSSAGE is a non phosphate cleaner disinfectant and sanitizer designed for general use in industrial areas where housekeeping is of prime importance in controlling the unsightliness of mold and mildew. When used as directed RC DÉMOUSSAGE is formulated to disinfect inanimate hard surfaces (such as walls, floors, sinks, toilet bowls, tables, chairs, telephones, roofs, tennis courts, and fences, etc.) In addition, RC DÉMOUSSAGE deodorizes those areas which generally are hard to keep fresh smelling, such as garbage storage areas, empty garbage bins and cans, toilet bowls, and any other areas which are prone to odours cause by microorganisms. RC DÉMOUSSAGE detergent/disinfectant has been designed specifically for offices, motels, nursing homes, and schools.

DISINFECTION - To disinfect hard inanimate surfaces (such as walls, floors, table tops, roofs, tennis courts, fences, etc.) apply solution with mop, cloth, or sponge so as to wet thoroughly. Allow to remain wet for 10 minutes and then let air dry.

DILUTION RATES - General Disinfection: add 16 mL of RC DÉMOUSSAGE per L of water. To disinfect toilet bowls: flush toilet, add 80 mL RC DÉMOUSSAGE detergent/disinfectant directly to the bowl water. Swab the bowl completely using brush or toilet mop, making sure to get under the rim. Let stand for 10 minutes and flush. For heavily soiled areas: a pre-cleaning step is required and recommended with Solvanet or Tartrox. Prepare a fresh solution for each use.

DISINFECTION - At 16 mL per L dilution. RC DÉMOUSSAGE exhibits effective activity against the organisms: Salmonella choleraesuis and Staphylococcus aureus. At this level the product is also fungicidal against the Pathogenic Fungi, trichophyton mentagrophytes (athlete's foot).

At 16 mL per L dilution, RC DÉMOUSSAGE is an effective disinfectant and demonstrates disinfectant activity against Pseudomonas Aeruginosa.

MOLD AND MILDEWSTAT - RC DÉMOUSSAGE prevents and controls mold and mildew and the odours they cause on hard non-porous inanimate surfaces at 16 mL per L dilution.

MILDEWSTAT - To control mold and mildew on pre-cleaned, hard non-porous surfaces (such as floors and walls) add 16 mL RC DÉMOUSSAGE per L of water. Apply solution with a cloth, mop, or sponge making sure to wet all surfaces completely. Let air dry. Prepare a fresh solution for each use. Repeat application at weekly intervals or when mildew growth reappears.

Rinse the emptied container thoroughly and add the rinsings to treatment site. Follow provincial instructions for any required additional cleaning of the container prior to its disposal or reconditioning. Dispose of the container in accordance with provincial requirements. For information of the disposal of unwanted product and the cleanup of spills contact the regional office of Environment Canada.

For small spills. Recover free liquid. Soak up residue with solids absorbent. DO NOT FLUSH INTO SURFACE STREAMS. INFORM ENVIRONMENT CANADA AS IN PREVIOUS PARAGRAPH.
