In case of contact, immediately flush eyes or skin with plenty of water. Get medical attention if irritation persists. If swallowed, induce vomiting and get medical attention.

DIRECTIONS FOR USE

APACHE FLY BAIT is an advanced formula bait containing TRICOLURE Sex Attractant and feeding adjuvants which attract both sexes of the housefly and many other pest fly species including little houseflies, flesh flies, blow flies and eye gnats directly to the bait. Bait should be applied to specified areas of high fly population daily or as needed to reduce fly populations. Scatter bait from container or other device at the rate of approximately 250 g per 100 square meters of fly feeding area. Use APACHE FLY BAIT in and around feedlots, dairies, stables, broiler houses, hog houses, livestock barns and kennels. Bait may also be used on walkways in caged layer houses. Apply only to areas out of reach of animals.

For use in the APACHE TP BAIT STATION: Fill bait chamber to bottom of hopper by pouring 60 g of bait into hopper. Use at the rate of approximately two bait stations per 50 square meters of fly feeding area. Hang bait stations out of reach of food producing animals, or set on ground or other surface only in areas inaccessible to food producing animals, pets and children.

STORAGE AND DISPOSAL

STORAGE

Store in cool dry place inaccessible to children and pets.

PESTICIDE DISPOSAL

Follow provincial instructions for any required cleaning of the container prior to its disposal. Make the empty container unsuitable for further use.
