DIRECTIONS: Shake well before using. Close doors and windows and other openings and remove all animals from buildings before application. Apply with a mist fogger (non-thermal) or manual pump at a rate of 200 mL per 100 m3. Wear mask or respirator and protective clothing. Apply to cracks, crevices and wall surfaces. Direct spray upwards, towards ceilings and walls or straight on insects. Keep area closed for 10-20 minutes after fogging. Ventilate thoroughly before re-entering treated areas. Repeat as necessary. When using a mist fogger, the equipment must be maintained and operated in accordance with the manufacturer's instruction manual.

NOTE: Treatment should be made only before or after milking.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Not for use on humans or animals. Apply only when the dairy is not in operation. Cover or remove all food processing surfaces, milk utensils, and dairy processing equipment. After spraying, wash all surfaces that may

contact milk food and rinse thoroughly with potable water before reuse. Avoid contamination of feed and water troughs.

Thoroughly clean all food processing equipment with potable water before resuming operations. Avoid contact with skin. Do not inhale spray mist. Wash after using. Do not store near food water or litter. Keep in original container during storage. Store in a cool, well ventilated place. Do not use in areas where beekeeping equipment or supplies are being stored. Do not contaminate any body of water. Toxic to fish.
