DIRECTIONS FOR USE

For maximum effectiveness of AQUA CLEAR inn swimming pools, heated swimming pools, exterior whirlpools and hot baths, those with heavy growths of algae should be cleaned prior to using AQUA CLEAR. For pools having just visible algae growth, add an initial dose of 450 - 750 mL of AQUA CLEAR per 10,000 L of water and remove settled algae debris by cleaning.
