Shake well before and occasionally during use.

APPLICATION INFORMATION: FOR PREMISES - Works up to 30 days against fleas. Thoroughly clean and vacuum your home. Seal vacuum bag and dispose in garbage. Spray Hartz 2 in 1 (R) Household Flea & Tick Killer Spray on any area that may be harbouring fleas. This usually includes pet resting areas, furniture, under beds, hallways, closets, etc. Flooring, particularly carpets, should be sprayed thoroughly. NOTE: WE RECOMMEND PATCH TESTING CARPETS AND FURNITURE ON A HIDDEN AREA, AND ALLOW THESE AREAS TO DRY BEFORE APPLICATION. We recommend you limit vacuuming to high traffic areas for 30 days. The product has extended residual activity. It continues working up to 30 days against fleas. Repeat application as needed.

FOR PETS - Works up to 8 days. Hold container 25-30 cm (10-12

inches) from your pet. Start by spraying its head (avoid contact with eyes and mouth) and work your way back to the hind quarters. Spray under the coat by backcombing against the direction of hair growth with your hand. To ensure adequate coverage, it is important to thoroughly wet, but do not soak, the entire coat and any exposed skin with product. Be sure to apply spray to the foot pads, between the toes, and to any other areas where fleas may avoid contact with the insecticide. Allow your pet to dry. Do not towel dry as this may remove the product. The spray adheres to the haircoat to provide at least eight days residual activity. If necessary, reapply weekly.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Avoid contact with eyes. Avoid breathing spray mist. Do not apply to nursing females or puppies and kittens under 8 weeks of age. Do not use on sick animals. Do not use on animals under drug or pesticide treatment. Before using on pregnant animals consult a veterinarian. Keep container closed when not in use. Cover or remove fish bowls and aquaria. Do not contaminate food utensils, feed or water. Wash hands after spraying and before eating or smoking. Do not use in nurseries or rooms where infants, ill or aged persons are confined. This product may pose a hazard to pollinating insects.

FIRST AID: In case of contact with eyes, immediately flush with plenty of water. If irritation persists, get medical attention. If on skin, wash with soap and water. If swallowed, see physician.

CAUTION - CONTAINS A PETROLEUM DISTILLATE. IF SWALLOWED, DO NOT INDUCE VOMITING.

DISPOSAL: Do not reuse empty container. Wrap in newspaper and dispose in garbage.
