DIRECTIONS FOR USE: To be used in the manufacture of insecticides which are registered under the Pest Control Products Act. This product is to be used with approved toxicants, carriers and propellents to produce an insecticide spray where the ratio of 1:1.25:1.25 of pyrethrins, piperonyl butoxide, and MGK 264 is desired. Read technical bulletin for formulation details.

PRECAUTIONS: Harmful if swallowed, inhaled or absorbed through skin. Causes eye irritation. Avoid contact with skin and eyes. Avoid contact with clothing. Wash thoroughly after handling. Avoid breathing vapors. Avoid contamination of food and feedstuffs.
