### DIRECTIONS FOR USE

Whitmire(R) PT 270 Residual is for use only with injection tube and for injecting into cracks and crevices where insects may be hiding, living and breeding. Place injector tip 2 cm into cracks, crevices, holes and other small openings where insects may be a problem. Release approx. 1 second spray per spot in serious infestation, if possible, place spots approx. 30 cm. In light infestation or preventative treatment, place spots approx. 1 metre apart. See the additional directions below for effective control of specified insects.

CRAWLING INSECTS: COCKROACHES, SPIDERS, TICKS, EARWIGS, CRICKETS, SOWBUGS, MILLIPEDES, CENTIPEDES: Spray into hiding places such as cracks and crevices, moist areas, openings around pipes and sinks, under refrigerators, behind baseboards, meter boxes and manholes. Spray directly on insects in these locations where possible.

BOOKLICE & SILVERFISH: Spray cracks and crevices in baseboards, door frames, bookcases and storage areas. Spray directly on insects in these locations where possible.

ANTS: Spray into trails, nests and points of entry around doors, windows, structural cracks and crevices. Spray directly on insects in these location where possible.

GRAIN WEEVILS, FLOUR BEETLES, CHOCOLATE MOTHS, DRUG STORE BEETLES(in exposed adult and larvae stages) and hibernating stages of BOXELDER BUGS, ELMLEAF BEETLES, CLUSTER FLIES AND CLOVER MITES. Contact as many insects as possible when treating infested areas such as cracks and crevices, in wall voids, around windows and door frames, under siding, in machinery, and in dark secluded areas.

FOOD HANDLING ESTABLISHMENTS: Limit to crack and crevice treatment only. Apply a small amount of material directly into cracks and crevices such as expansion joints between different elements of construction or between equipment bases and floor, wall voids, motor housing, junction boxes or switch boxes, conduits or hollow equipment legs where insects hide. Avoid

contamination of food or food processing surfaces. In food processing plants use only when plant is NOT in operation. Remove or cover all food, food processing equipment, packaging materials and utensils before application. After application wash all surfaces that may contact food and rinse with potable water before re-use for food processing.

## PRECAUTIONARY STATEMENT:

Harmful if swallowed, inhaled, or absorbed through the skin. Avoid contact with eyes, skin, clothing and avoid inhalation of vapours or spray mist. Wash thoroughly after handling and before eating, drinking, etc. KEEP OUT OF THE REACH OF CHILDREN. Do not apply to plants, animals or humans. Remove pets and fishbowls from area before treatment and do not return them for at least 4 hours after treatment. Do not apply to surfaces that children or pets might contact.

DO NOT CONTAMINATE FOODSTUFFS. Do not use in any areas where food may be exposed. Do not use in bulk food storage areas. Do not use in cupboards where food or cooking utensils are stored.

Hospitals: in homes or dwellings, remove or cover all exposed food and cooking utensils before spraying. Thoroughly wash all surfaces that might contact food before re-use. Do not use in nurseries or rooms where infants, ill or aged persons are confined. Do not allow humans or pets to contact treated surfaces until spray has dried.

In meat and food processing plants and food service establishments, treat only when plant is NOT in operation. Remove or cover all food packaging materials and utensils and cover all food processing surfaces before spraying. After treatment, wash all surfaces that may contact food and rinse thoroughly with potable water before resuming operations. Do not use in rooms where milk is processed, handled or stored. Do not store or spray near open flame or stove.

Contents under pressure. Do not puncture or incinerate container. Do not use or store near heat or open flame. Exposure to temperatures above 55 deg C may cause bursting.

Do not spray on plastic, painted or varnished surfaces or directly into any electronic equipment such as radios,

televisions, computers, etc.

#### FIRST AID:
