This formulation gives rapid control of insects listed below. Spray residue kill insects after the spray deposit has dried. Ants, brown dog ticks, clover mites, crickets, earwigs, fleas, millipedes, cockroaches, silverfish, and spiders.

DIRECTIONS: Spray surfaces to wetting. Point spray away from people, plants, and pets.

Indoor use: Ants, cockroaches, crickets, silverfish, spiders: Spray into cracks, crevices around baseboards and other places where these insects hide. Apply behind and beneath cabinets, refrigerators, sinks, stoves and in and around waste container. Repeat as needed. Do not spray foodstuffs or plants. For ants, spray trails and places where ants enter premises. Do not allow anyone into treated areas until completely dry. Brown dog Ticks: Spray sleeping quarters of dogs, around baseboards, window and door frames, wall cracks, and local areas of floors. Repeat as needed. Fresh bedding should be placed in animal quarters after spraying. Do not spray animals. Outdoor use: Ants, clover mites, crickets, earwigs, fleas, millipedes and Brown dog ticks: Spray infested areas thoroughly including outside surfaces of screens, doors, window frames, foundation, patios or other places where insects may enter. For ants spray hills and runways. Repeat as necessary. Do not spray vegetation.

PRECAUTIONS: Keep out of reach of children. Harmful or fatal if swallowed, inhaled or absorbed through skin. Avoid breathing of spray mist. and provide adequate ventilation of area being treated. Contact with skin, eyes, clothing should also be avoided. Wash thoroughly with soap and water. Flammable - explosive. Do not store above 50 °C. Do not use in the presence of spark or flame. Do not puncture or incinerate container. Avoid contamination of food, utensils, food preparation areas. Do not use in edible product areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed.

FIRST AID: In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. Wash contaminated clothing before re-use. If swallowed, drink promptly a large quantity of milk, egg whites, gelatin solution, or if these are not available, drink large quantities of water. Avoid alcohol. Call physician.

TOXICOLOGICAL INFORMATION: Probable mucosal damage may contraindicate the use of gastric lavage. Measure against circulatory shock, respiratory depression and convulsion may be needed. Propoxur is a cholinesterase inhibitor. Atropine is antidotal.

DISPOSAL: When container is empty, press valve to release all remaining pressure. Dispose of the container in accordance with provincial requirements. For information on the disposal of unused, unwanted product and the cleanup of spills, contact the
