CANOLA - CONTROL OF SCLEROTINIA STEM ROT

Rovral protects the crop during the critical flowering and early pod development periods. Some Sclerotinia may appear due to later infection.

RATE: 1-1.5 kg/ha Rovral as a ground application in 100 litres of water per hectare, or as an aerial application in at least 45 litres of water per hectare. The use of the higher rate is recommended for fields with a history of heavy disease pressure or for dense crop stands. Good coverage of the plants is essential. The addition of a non-ionic adjuvant registered for this purpose will improve performance. (Enough Super Spred adjuvant is enclosed for this 8 kg box.)

NOTE: Do not allow spray drift onto oats as injury may result.

TIMING: Apply Rovral when the corp is in the 20-30% bloom stage. For Argentine varieties, the correct stage for application is when 15-20 flowers are open (including small pods) on the main stem. For Polish varieties, the correct stage for application is when 11-15 flowers (or small pods) are open on the main stem.

## AERIAL APPLICATIONS:

- 1. The crop must be treated at the RECOMMENDED growth stage. Crop stage must be checked prior to spraying.
- Rovral must be applied in volume rates of NOT LESS THAN 45 L/ha.
- 3. The recommended rate of Rovral must NOT be reduced.
- 4. Effective swath width (as determined by boom width and spray pattern overlaps) must be accurately maintained. Conduct tests to determine the effective swath width of your aircraft. (For example the effective swath width may be less than one half of overall swath.)
- 5. Flat-fan or hollow cone nozzles are recommended.
- Nozzles should be positioned to compensate for prop-wash and wing-tip vortex effects. Nozzles should not be placed within 1 metre of wing tips.
- 7. Nozzle orientations (measured from direction of flight) to achieve desired minimum droplet density with maximum coverage.

- 8. Efficient bout-marking is essential. ("Automatic Flagman" marker should only be used as a back-up system).
- 9. Spraying should be carried out in a crosswind wherever possible.

10. Avoid spraying in a dead calm and when wind speed exceeds 20 km per hour.

DIRECTIONS: Put one half the required water volume in the spray tank, stir in Rovral and add the remainder of the water. Ensure mixing is complete and agitate thoroughly before each application and continue to agitate during spraying. A prepared spray mixture should be used as soon as possible in the same day, especially if the water used for mixing is alkaline (greater than pH of 7). Rovral should not be mixed with other pesticides, adjuvants or fertilizers except where stated.

FIRST AID & TOXICOLOGICAL INFORMATION: Remove any contaminated clothing. Wash exposed skin with soap and water. In case of eye contamination, flush with water or 1% saline solution. If ingested and patient is unconscious, wash out mouth and obtain medical attention immediately. If breathing is affected, begin artificial respiration and obtain medical attention immediately.
