DIRECTIONS FOR USE

Apply Betco(R) 256 to walls, floors and other hard (inanimate) non-porous surfaces such as tables, chairs, countertops, sinks, tile, porcelain, and bedframes with a cloth, mop so as to thoroughly wet surfaces. For heavily soiled areas, a preliminary cleaning is required. Prepare a fresh solution daily or when use solution becomes visibly dirty.

DISINFECTION: To disinfect hard, non-porous surfaces, add 4 mL/L of water. Treated surfaces must remain wet for 10 minutes. At this use level. Betco(R) 256 is also virucidal and fungicidal.

AOAC Fungicidal Test: This product is effective against Trichophyton mentagrophytes.

Mildewstatic Performance: At 4 mL/L Betco(R) 256 will effectively inhibit the growth of mold and mildew and the odours caused by them, on hard non-porous surfaces. Allow to dry on surface and repeat when mildew growth returns.
