DIRECTIONS FOR USE

For Cleaning: Lightly soiled areas - surfaces to be cleaned should be mopped or brushed with a solution containing 9 mL of WACO QUAT per litre of water. Rinse cleaned area with fresh potable water.

Heavily soiled areas - mop or brush soiled surfaces with a solution containing 19 mL of WACO QUAT per litre of water. Rinse cleaned surface with fresh potable water.

General Disinfection: To disinfect walls, floors and other hard surfaces in schools, restaurant rest rooms and other public areas, mop or brush surface to be treated with a solution containing 9 mL of WACO QUAT per litre of water. Surfaces that are heavily soiled should be cleaned with 16 mL of WACO QUAT per litre of water and then disinfected. Those surfaces which may later come in contact with food must be rinsed with clear water of drinking quality.

To disinfect locker rooms, shower stalls, walkways around pools and other areas against pathogenic fungi, mop area with a solution containing 5 mL in 1 litre of water. This solution will destroy *Trichophyton Interdigitale*, a causative agent of athlete's foot.

Hospital Disinfection: To disinfect walls, floors, furniture and other hard surfaces in hospital and nursing homes, mop or brush surface to be treated with a solution containing 16 mL of WACO QUAT per litre of water. Those surfaces that are heavily soiled with blood, fecal material or exudates should be thoroughly scrubbed with a solution containing 16 mL per litre of water and then rinsed with a fresh solution containing 16 mL per litre of water before disinfection.

Sanitization: (Including Equipment in Food and Meat Processing Plants)

To sanitize walls, floors and equipment in food processing plants, first clean thoroughly with a solution containing 9 mL of WACO QUAT per litre of water. If surface is heavily soiled use WACO QUAT at a rate of 19 mL per litre to ensure thorough cleaning. Sanitize cleaned surface with a rinse solution containing 3 mL of WACO QUAT per litre of water. Food contact surfaces must be rinsed with potable water before reuse.

Deodorization: To deodorize surfaces during cleaning, mop or brush surfaces with a solution containing 16 mL of WACO QUAT per litre of water. WACO QUAT is an effective industrial and institutional cleaner.

Precautionary Statements: KEEP OUT OF REACH OF CHILDREN. Corrosive. Causes eye damage and skin irritation. Do not get in eyes, on skin or on clothing. Protect eyes and skin when handling. Harmful if swallowed. Avoid contamination of food, and use of food-contact surfaces must be followed by a thorough rinse with potable water.

Toxicology Information: Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression and convulsions may be needed.

First Aid: In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes and call a physician. Remove and wash contaminated clothing before reuse. If swallowed, drink promptly a large quantity of milk, egg whites, gelatin solution or if these are not available, drink large quantities of water. Avoid alcohol. Never give anything by mouth to an unconscious person. Call a physician immediately.
