USE DIRECTIONS:

Q-Bac liquid is a concentrate which should be used in diluted form.

For disinfection dilute 6-12 mLs. per litre of cold or hot water.

For sanitizing dilute 3-9 mLs. per litre of cold or hot water.

For deodorizing and cleaning of hard surfaces dilute 2-6 mLs. per litre of cold or hot water.

Surfaces subject to direct food contact must be thoroughly rinsed with potable water.

Suitable for all manual cleaning operations.

DISPOSAL:

1. Rinse the emptied container thoroughly and add the rinsings to the treatment site.
2. Follow provincial instructions for any required additional cleaning of the container prior to its disposal or reconditioning.
3. Dispose of the container in accordance with provincial requirements.
4. For information on the disposal of unused, unwanted product and the cleanup of spills, contact the regional office of the Conservation, Protection Branch, Environment Canada.
5. For small spills: Recover free liquid. Soak up residue with solids absorbent. Make container unsuitable for further use. DO NOT FLUSH INTO SURFACE STREAMS. INFORM ENVIRONMENT CANADA AS IN NO. 4.

PRECAUTIONS: If used on food contact surfaces, rinse thoroughly with potable water...avoid contamination of food.
