NOTICE TO USER

This control product is to be used in accordance with directions on this label. It is an offence under the Pest Control Products Act to use a control product under unsafe conditions. This product is to be used only as an antifouling paint on underwater

surfaces of ships and boats.

DIRECTIONS

Large Vessels: Vessels over 25 metres must be treated by trained applicators. Surface Preparations: Steel surfaces must be clean, dry and free of rust. New steel surfaces should receive one coat of MATCHLESS SUPER MARINE Anti-Corrosive Primer followed by a coat of MATCHLESS Antifouling Bottom Paint. Previously painted surfaces should be cleaned and spot primed with MATCHLESS SUPER MARINE Anti-Corrosive Primer before applying the MATCHLESS Antifouling Bottom Paint. On wood, the surface need only be clean and dry before application of the MATCHLESS Antifouling Bottom Paint. Application: Stir well from the bottom of the can using a lifting motion, and apply by brush, roller or spray. Thinning: This paint should be applied directly from the can. However if thinning is required, or for spray painting, use up to 10% Mineral Spirits. DRYING TIME: This paint does not dry hard. The vessel should be put back in the water 4 to 12 hours after painting, and definitely within a 24 hour period. COVERAGE: 7 to 8 square metres per litre.

PRECAUTIONS

KEEP AWAY FROM HEAT, SPARKS AND FLAME. VAPOURS HEAVIER THAN AIR CAUSE HEALTH AND EXPLOSION HAZARDS. KEEP CONTAINERS TIGHTLY CLOSED WHEN NOT IN USE. AVOID CONTACT WITH EYES, SKIN, AND CLOTHING. DO NOT BREATHE VAPOURS OR SPRAY MIST. USE AN AIR-FED RESPIRATOR WITH FULL FACE MASK DURING HANDLING AND APPLYING. WEAR CHEMICAL RESISTANT GLOVES AND FOOTWEAR, AND CHEMICAL RESISTANT CLOTHING WITH HEAD COVERING AT ALL TIMES DURING HANDLING AND APPLYING. KEEP OUT OF REACH OF CHILDREN. HANDLE WITH CARE AND MIX ONLY IN A CLOSED CONTAINER. USE ONLY IN WELL VENTILATED AREAS. WHEN USING DO NOT EAT, DRINK OR SMOKE. TAKE A SHOWER IMMEDIATELY AFTER WORK. WEAR FRESHLY LAUNDERED CLOTHES DAILY. WASH HANDS AND FACE BEFORE EATING, DRINKING, SMOKING AND USING THE TOILET. STORE AND WASH ALL PROTECTIVE CLOTHING SEPARATELY FROM HOUSEHOLD LAUNDRY. WASH PROTECTIVE CLOTHING IN DETERGENT AND HOT WATER BEFORE REUSE.

FIRST AID

Inhalation: Move victim to fresh air. If breathing is difficult administer artificial respiration. Contact Physician. Skin Contact: Remove contaminated clothing. Wash with soap and water.
