DIRECTIONS: Shake well before use. Wilson's low-toxicity House Plant Insect Killer may be used on potted plants or in small gardens and greenhouses. Use can in upright position. Ensure valve points toward surface to be sprayed. Hold at least 1/2 METRE FROM PLANTS and 1 METRE FROM SURFACES WHICH MAY STAIN. Spray in short bursts and allow mist to drift onto both upper and lower surfaces of leaves. Very little spray is needed to kill insects. Do not over-spray. Repeat as necessary.

Kills Aphids, Cyclamen Mites, Two Spotted Mites (Red Spiders), Whiteflies on African Violet, Azalea, Begonia, Calceolaria, Cineraria, Chrysanthemum, Cyclamen, Daffodil, Dieffenbachia, Euonymus, Fuchsia, Gardenia, Geranium, Gloxinia, Hibiscus, Hoya, Hyacinth, Ivy, Jerusalem Cherry, Lantana, Lily, Maranta, Marigold, Orange, Peperonia, Petunia, Rose, Snapdragon, Tulip, Zinnia.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Avoid breathing spray mist. Avoid contact with skin, eyes, clothing, feed and food. Remove pets, birds and cover aquariums and food utensils before spraying. Do not spray edible plants. Avoid Freezing.
