DIRECTIONS: Attach dispensers firmly to the trellis wires in early May, prior to the emergence of the Grape Berry Moth. Rate of placement to be 1,000 dispensers per hectare, evenly spaced on every row. Refer to the General Information brochure for detailed instructions.

STORAGE: Store dispensers in their sealed packs until ready to start hanging in the field. Until then, store in a cool place. Do not contaminate water, feed or food in storage.

DISPOSAL: Dispose of the empty dispensers and foil packs in accordance with Municipal regulations. For further information

on disposal of unused material, contact the regional office of Conservation & Protection, Environment Canada.

GENERAL PRECAUTIONS: Avoid eye contact and wash hands with soap and water after handling.

FIRST AID: In case of eye contact, flush with plenty of water. Wash hands with soap and water after handling dispensers.
