DESCRIPTION:

Bolt Liquid Airborne has two big PLUS features:

1. Its Power-Packed Formula! 2. Contains no DDT.

It is a fast acting space spray with highly effective knockdown power, especially made for use in institutions...in restaurants,

hotels, motels and other commercial establishments...in food and dairy plants, in-plant restaurants and cafeterias, and other industrial locations...and in schools and colleges.

Bolt Liquid Airborne quickly kills many flying insects in spray mist including flies, mosquitoes, wasps, flying moths, and gnats. Wetting by direct spraying kills many crawling insects including roaches, ants, silverfish, fleas and bedbugs.

CAUTION: COMBUSTIBLE MIXTURE

Do not use or store near heat or open flame. Do not smoke while spraying.

DIRECTIONS: For best results use a good, clean sprayer - free of rust - which produces a fine mist.

For Flying Insects: Flies, Mosquitoes, Flying Moths, Gnats, Wasps: Close doors and windows. Spray freely towards ceiling in all directions until room is fogged with mist, using 28 to 56 mL per 28.3 cubic meters of space. When spraying, keep about 1 meter from interior walls, fabrics and furniture. Doors and windows may be opened after 10 minutes.

For Crawling Insects: Roaches, Silverfish, Crickets: Spray thoroughly into cracks and crevices, under and behind sinks, cupboards, drawers, woodwork, refrigerators, pipes, and drains where these insects hide. Spray directly on as many insects as possible. Repeat application as necessary.

Moths and Carpet Beetles: Bolt Liquid Airborne kills these insects, their eggs and larvae by contact. Clear and spray closet thoroughly to reach all hiding places. Clean and brush woolen articles. Repeat application every 30 days. Where carpets are infested, spray both sides thoroughly. When spraying near fabrics, keep spray in constant motion at least 1 meter away from the fabrics. Spraying closer may cause stains.

Bedbugs: Spray baseboards, molding, floor boards. Spray mattresses particularly around seams and tufts. Take bed apart and spray into all joints. Repeat application as necessary.

Ants: Spray trails, hills, around window sills and openings around pipes and baseboards where ants crawl, hitting as many as possible. Repeat application as necessary.

Fleas: Spray floors, floor coverings, and sleeping quarters of pets and other infested areas. Repeat as required. Do not spray pets.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed. Avoid direct spraying of foodstuffs, dishes, utensils. Do not use on humans, pets or plants. Cover bird cages and fish bowls before using spray. Keep spray in constant motion at least 1 meter away from walls, fabrics, furniture, floors, plastics, etc. Spraying closer may cause stains. Most asphalt tile, some linoleum and certain plastic materials have a tendency to discolor and to soften when wet with petroleum base insecticides. Before spraying, test such materials by applying to small inconspicuous areas.

Use in food processing plants only when plant is not in operation. Food should be removed or protected during treatment. All food processing surfaces should be covered or thoroughly cleaned before again using for food.

DISPOSAL:

- 1. Rinse the emptied container thoroughly and add the rinsings to the spray mixture in the tank.
- 2. Follow provincial instructions for any required additional cleaning of the container prior to its disposal.
- 3. Make the empty container unsuitable for further use.
- 4. Dispose of the container in accordance with provincial requirements.
- 5. For information on the disposal of unused, unwanted product and the cleanup of spills, contact the Provincial Regulatory Agency or the Manufacturer.

NOTE: Treat food processing plants early in the season before canning or other processing begins. Repeat applications if necessary when this plant is not in operation. Remove or cover any exposed food products, equipment or packaging materials before spraying. Rinse all equipment with water before resuming operation.
