TOXICOLOGICAL INFORMATION

Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. If exposed, plasma and red blood cholinesterase tests may indicate degree of exposure (baseline data are useful). Atropine, only by injection, is the preferable antidote. Oximes, such as Pralidoxime Chloride, may be therapeutic if used early; however, use only in conjunction with atropine. Supportive care. Treatment based on judgement of the physician in response to reactions of the patient.

STORAGE

- 1. Do not store near food, feed, seed, fertilizers or other pesticides.
- 2. Keep in original container during storage.
- 3. Store in a cool, dry, well-ventilated place. Keep away from moisture and temperature above 50EC.

DISPOSAL
