DIRECTION FOR USE: For use as crack and crevice treatment or spot treatment only. Spray surfaces until wet. Do not spray people, plants or pets. Do not allow children or pets to contact treated surfaces until surfaces are completely dry.

INDOOR USE: KILLS ANTS, spiders, cockroaches, crickets, silverfish, sawtoothed grain beetles(exposed stage): Spray into cracks and crevices around baseboards and other places where these insects hide. Apply behind and beneath cabinets, refrigerators, sinks, stoves and in and around waste containers.

Repeat as needed. Do not spray foodstuff or house plants. Avoid contamination of food, utensils, and food preparation areas. Do not use where food is prepared, handled or stored. Avoid excessive wetting of plastic, rubber and asphalt surfaces such as tiles and floor coverings.
