"DO NOT APPLY BY AIR". Superior 70 Spray Oil is an emulsifiable type of mineral oil for use in the control of insects and mites attacking apples, cherries, peaches, pears and plums. Mixing Superior 70 Spray Oil with sulphur compounds may reduce emulsification.

Do not use Superior 70 Spray Oil on Red Delicious, Empire and Mutsu apples as the oil may cause bark injury. To prevent damage to plant life, apply only under proper conditions. Avoid spraying during or just prior to freezing weather or rain. While thorough coverage is important, avoid over spraying. Plants should be sprayed only when in a healthy condition. Use efficient spraying equipment. For further information as to the use of dormant oil sprays, consult local pest management specialists.

RUTABAGAS: Superior 70 Spray Oil can be used on rutabagas to deter the feeding of aphids, which spread Turnip Mosaic Virus. Apply 11 litres/hectare of Superior 70 Spray Oil in 550-1100 litres/hectare of water. Thorough coverage is essential. Application should be made at 2500 kPa with hollow cone nozzels. Spray at one week intervals beginning in mid-June or at the first appearance of aphids in the local area. Consult your local extension office for more precise information about aphid activity and spray timing. Do not apply closer than 21 days to harvest. CAUTION: Do not apply Superior 70 Spray Oil in direct sunlight. Spray rutabagas early in the morning or evening. Allow at least 24 hours to elapse after the Superior 70 Spray Oil application before applying other insecticide sprays. Do not apply Superior 70 Spray Oil in more concentrated solutions than recommended as crop injury may occur.

Procedure for Mixing Spray Oil:

Before mixing be certain that the spray tank is clean. To mix, add water to the level of the agitator shaft and with the agitator in motion, pour in the required amount of Superior 70 Spray Oil. The mixture should turn white indicating good emulsion. After mixing, continue filling the tank and do not stop agitation until contents have been sprayed out.

DO NOT USE THIS MATERIAL IF IT DOES NOT EMULSIFY.
