## GENERAL:

A READY TO USE FORMULATION OF THE INSECTICIDE PROPOXUR FOR RAPID KNOCKDOWN AND KILL OF ADULT MOSQUITOES AND BLACK FLIES IN OUTDOOR AREAS. MAINTAINS THE KILLING EFFICIENCY AT LOW TEMPERATURES.

## DIRECTIONS

READ AND UNDERSTAND THE DIRECTIONS FOR THE FOGGER BEING USED. Fill the insecticide tank of the fogger as directed. For best results in smaller areas, apply a dense fog when the air is calm Allow the fog to drift over the area to be treated to contact as

many insects as possible. Fog while moving away from the area being treated. Apply the fog to envelop completely the area being treated, contacting as many insects as possible. The best time to fog is when most of the Mosquitoes or Blackflies are actively flying; that is evening or early morning; at this time there is generally little wind and rising air currents are at a minimum. Larger areas will be covered more easily if applications are made when the winds are light and at right angles to the wind. Under these conditions, fog will drift approximately 90 metres downwind. Allow the fog to dissipate before occupying the treated area.

Application should be at the rate of 30 mL FOG OIL #1 per 100 square metres of area being treated.

## MAINTENANCE OF FOGGING EQUIPMENT:

Flush fogging equipment immediately after use. A few minutes spent in proper equipment maintenance will reduce problems. Procedure for portable foggers: Dyna Fog, Swingfog, Fogmaster:

- 1. Drain fogger insecticide tank.
- 2. Pour 250 mL Ditchling Fogger Flushing Solvent into insecticide tank.
- 3. Replace insecticide tank cap and "rock" fogger to loosen any residue.
- 4. Start machine outdoors, and fog until tank is empty.
- 5. Loosen insecticide cap to relieve pressure.
- 6. Remove insecticide filter and rinse in Fogger Flushing Solvent.

PRECAUTIONS: May be harmful if swallowed. KEEP OUT OF REACH OF CHILDREN. Avoid inhalation or skin contact. Wash thoroughly after using. Do not contaminate feed or food and do not apply to croplands. Avoid contamination of animal feeding areas, such as pastures and other foraging areas. Do not contaminate water supplies, streams, lakes or ponds. Do not use as an indoor space spray. Do not apply to animals or humans.

DO NOT FOG WHERE HUMANS OR ANIMALS ARE DIRECTLY DOWNWIND OF THE TREATMENT [ WITHIN 100 METRES ]. Toxic to bees. Do not treat plants directly. Do not reuse empty container.

DISPOSAL: Follow provincial instructions for any required cleaning of the container prior to its disposal. Make the empty container unsuitable for further use. Dispose of the container in accordance with provincial requirements. For information on the disposal of unused, unwanted product and the cleanup of spills, contact the regional office of Conservation and Protection, Environment Canada.

FIRST AID: Danger. This product contains petroleum distillates. If swallowed do not induce vomiting. Seek medical attention immediately. If patient is unconscious give them air. Do not give anything by mouth to an unconscious person. If on skin, remove contaminated clothing and wash skin thoroughly with soap and water. If in eyes flush with water for 5-10 minutes and obtain medical attention immediately.

TOXICOLOGICAL INFORMATION: Propoxur is a cholinesterase inhibitor. Atropine is antidotal. Do not give Morphine. Watch for pulmonary edema, which may develop in serious cases of poisoning even after 12 hours. At first sign of pulmonary edema, the patient should be placed in an oxygen tent and treated symptomatically.
