At a 1:20 dilution (50mL/L of water), B-QUAT is a germicide and disinfectant against Staphylococcus aureus, Salmonella typhosa, Trichophyton interdigitale, Salmonella choleraesuis.

At a 1:60 dilution (16mL/L of water), B-QUAT is a very good sanitizer deodorizer because it destroys odour causing bacteria.

DIRECTIONS: To clean and sanitize floors, walls, sinks, toilets, etc. use 1 part B-QUAT to 60 parts water.

PRECAUTIONARY STATEMENTS: Keep out of reach of children.

Caution - Concentrated and diluted product can cause eye and skin irritation. Do not get in eyes, on skin or on clothing. Harmful if swallowed. Avoid contamination of food.

FIRST AID: In case of contact immediately flush eyes or skin with plenty of water for at least 15 minutes. If irritation persists, call a physician. If swallowed, drink promptly large quantities of milk, egg whites, gelatin solution, or if these are not available drink large quantities of water. Avoid alcohol. Call a physician immediately.

TOXICOLOGICAL INFORMATION:

Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression and convulsions may be needed.

DISPOSAL:

1. Rinse the emptied container thoroughly and add the rinsings to treatment site.
