DIRECTIONS FOR USE

To be used only in the manufacture of a pesticide which is registered under the Pest Control Products Act

PRECAUTIONS

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. May cause sensitization. Avoid contact with skin, eyes or clothing. Avoid breathing dust or spray mist. Wear a long-sleeved shirt, long pants, shoes plus socks, waterproof gloves, eye goggles and a dust/mist filtering respirator (MSH/NIOSH approval number prefix TC-21C) or a NIOSH approved respirator with any N-95, R-95, P-95 or HE filter for biological products when handling the product and during all clean-up/repair activities. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse.

ENVIRONMENTAL HAZARDS

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

FIRST AID

- If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

- If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

General: Seek medical attention immediately if irritation or signs of toxicity occur and persist or is severe. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION

Treat symptomatically.

STORAGE AND DISPOSAL

Do not contaminate water, food or animal feedstuffs by storage or disposal. Do not contaminate water by cleaning of equipment or disposal of wastes.

STORAGE: Store in a dry place and at temperatures between 1°C and 30 C away from direct sunlight. Keep in original container during storage. Store product in cool, dry, well-ventilated place away from seed, feed, fertilizer or other pesticides. Keep away from fire or open flame, or other source of heat
