DIRECTIONS: Remove collar from package and place around cat's neck. Adjust for proper fit and buckle in place. Collar must be

Some cats may be sensitive to this collar. When collar is first worn observe neck area every few days for irritation. Any collar, when fastened too tightly, may cause skin irritation. Remove collar at the first sign of irritation or adverse reaction. Collar is intended for use as an insecticide generator and is not to be taken internally by man or animal. Do not use on sick or convalescing animals. DO not administer other cholinesterase inhibitors (i.e. oral pesticides) while collar is worn or for a few days after removing collar.

PRECAUTIONS: Do not open inner envelope until ready to use. DO NOT ALLOW CHILDREN TO PLAY WITH UNATTACHED COLLAR. Dust will form on this collar during storage. Do not get dust or collar in mouth, harmful if swallowed. Wash hands thoroughly with soap and water after handling collar.

FIRST AID: In case of poisoning, call a physician immediately. If dust from collar contacts skin, wash thoroughly with soap and water. If dust contacts eyes, flush eyes with water and get medical attention.

TOXICOLOGICAL INFORMATION: Dust in eyes will cause temporary pupillary constriction*. Dust released from collar is a cholinesterase inhibitor. Atropine and homatropine* are antidotal.
