KILLS HORNETS, WASPS, BEES and other stinging insects. Best results are obtained when applications are made in early morning or evening when insects are at rest. STAND WELL AWAY FROM NEST, then spray directly into opening in short 2-3 second blasts so that the spray contacts inside nest entrance. If unable to locate nest, a heavy(contact & residual) spray around and into the openings where insects gain entrance will eventually eliminate the pests. Insects hit by spray or having contacted the sprayed surface will die soon after.

KILLS GARDEN PESTS: Kills Tent Caterpillars and Pine Sawflies on deciduous and evergreen ornamentals.

DIRECTIONS: The spray will reach from 6 to 8 metres so you will now be able to reach the insects high in your eaves, ceilings, or trees. The best time to spray is on a calm day so the wind does not affect the jet spray from reaching the pests.
