TOMLYN'S Flea & Tick AQUA SPRAY is designed to be used daily, providing effective 24 hour protection. It is a non-sticky water base spray utilizing pyrethrins.

DIRECTIONS: SHAKE WELL BEFORE USING. Hold can in upright position 25-30 cm from pet. Spray pet evenly beginning at the tail and moving forward covering the animal's entire body, paying special attention to neck and hindquarters. While spraying, fluff the animal's hair so spray will penetrate to the skin where most pests reside. Protect animal's eyes from spray. For best results spray TICKS thoroughly. Use daily as needed. Hair should be lightly damp but not saturated. For effective flea and tick control, treatment of the pet should be combined with the sanitation of any area used by the pet. Vacuum floors, carpets and furniture (discard vacuum bag after use) and wash the pet's bedding, living quarters and surrounding areas. If pest problems persist, an insecticidal premise treatment may be required.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Do not spray in eyes, or face or on genitals of pet. Discontinue use if dermal or nasal irritation develops. Consult a veterinarian before using on pregnant animals, sick animals or animals under drug or other pesticide treatment. Do not use on nursing animals or animals under 8 weeks of age. Discontinue use if adverse effects are observed. Do not use near fish, feed or foodstuffs. Avoid inhalation of spray. Wash hands after use.

DISPOSAL:

Do not reuse empty container. Dispose of empty container with household garbage.

FIRST AID: If sprayed in your eyes or on your skin, flush with clean water. If irritation persists, obtain medical attention. If accidentally swallowed, obtain medical attention or call Poison Control Centre at once.
