## CONTROLS OVER 50 VARIETIES OF LAWN WEEDS

CONTROLS: Dandelions, Plantains, Chickweed, Clover, Bedstraw, Black Medick, English Daisy, Curled Dock, Heal-all, Ground Ivy (Creeping Charlie), Knotweed, Ragweed, Shepherd's-Purse, plus over 35 other lawn weeds.

#### **DIRECTIONS:**

Adjust nozzle to provide desired spray pattern. Squeeze trigger to operate. Adjust nozzle to give coarse, wet stream. Aim at weed; pull trigger. Only short burst necessary.

- Apply when weeds are actively growing.
