Dex-Off outdoor repellent should be used in conjunction with training. For outdoor situations, the most effective control for a pet is the sharply spoken word backed up with disciplinary action.

DIRECTIONS FOR USE : Outdoors, to prevent your pet, or stray animals from soiling flower beds, areas of lawns, trees, shrubbery or evergreens, spray the edges of flower beds, trunks of trees, the bases of shrubbery and evergreens, patches of lawns, etc.

lightly every day or every other day with the repellent. Stray animals are frequently attracted to areas where urine or feces have been deposited. First, remove any droppings, then spray the spot with this masking odour. Re-apply as often as necessary until undesirable habits of your pet or stray animals are changed. Do not apply directly to foliage of shrubs or to ornamental, soft bodied plants. Apply only in areas adjacent to buildings. Do not apply in wildlife habitat areas (e.g., parklands, forested lands).

PRECAUTIONS : KEEP OUT OF REACH OF CHILDREN.

Avoid contamination of food and feedstuffs. Wash hands with soap and water before eating and smoking. Avoid contact with the skin. Wear rubber gloves when applying this product. Do not apply this product in a way that it will contact any person or pet, either directly or through drift. Do not apply to food/feed crops or animals. Do not allow persons or pets to enter the treated area until the spray has dried.

DISPOSAL: Do not reuse container. When container is empty dispose of it in household garbage.
