### **DIRECTIONS FOR USE:**

SHAKE WELL BEFORE USING. Point spray nozzle away from face and press button, holding container as upright as possible. Apply in short bursts. For use in and around the home. If reinfestation occurs, repeat application.

### FOR INDOOR USE:

For fast knockdown of flying insects, spray directly at insects, keeping about 1 metre from interior walls, fabrics, and furniture. DO NOT USE AS A SPACE SPRAY.

For residual control of flies around screens and doors, spray from a distance of 40 - 50 cm covering 1 square metre of surface area in 4 - 6 seconds. It is recommended to check for potential staining and damage in an inconspicuous place before complete treatment.

For WASPS, HORNETS, and YELLOW JACKETS: Spray directly at stray wasps that enter building, keeping about 1 metre from interior walls, fabrics, and furniture.

### FOR OUTDOOR USE:

Give special attention to breeding areas, such as around garbage cans. For control of fly eggs, spray around garbage cans from a distance of 40 to 50 cm covering 1 square metre of surface area in 4 to 6 seconds. When spraying be careful that spray does not contact painted surfaces of vehicles. Repeat as necessary.

**DISPOSAL:** When empty, press button to release pressure, discard in household garbage.
