# DIRECTIONS FOR USE:

ACTIVE DOG & CAT REPELLENT is a pleasantly fragranced non-pressurized spray that is not offensive to humans but effective in helping make your pets and stray animals get off your furniture, rugs, and those localized outside home and

garden areas, when used as directed. ACTIVE DOG & CAT REPELLENT is a useful dual product for those difficult localized areas, indoors and outdoors.

This product should be used in conjunction with training of animals. Both indoors and outdoors, the most effective control for a pet is a sharply spoken word in combination with disciplinary action, when necessary.

### INDOORS:

To alter your pets habits such as sleeping on rugs, furniture or other areas in your home, spray areas lightly to slightly moisten. To test the effect of this product, first treat a small inconspicuous area. This product may stain some fabrics or plastics.
