Notification Change

Safer's Rotenone Garden Dust is a safe ready-to-use insecticide that can be applied up to the day before harvest on edible crops as it has low persistence and produces no harmful residue on vegetable crops. As Rotenone is not phytotoxic, it can be applied to any ornamental plants without worry. Safer's Rotenone Garden Dust is ready-to-use. Do not mix with water.

DIRECTIONS FOR USE: Vegetables: To control aphids, asparagus beetles, bean leaf beetle, beet webworm, cabbage looper, Colorado potato beetle, cucumber beetles, diamondback moth, corn borer, flea beetles, horn worms, cabbageworm, leaf hoppers, bean beetles, pea weevil, pickle worm, squash vine borer and thrips, apply at the rate of 36-50 g per 10 m² as soon as insect damage is evident. Repeat 5 to 7 day intervals or as required. For squash vine borer, apply to the base of the plant, beginning when the first true leaves appear. For European corn borer, apply to the center of the leaf whorls after the last eggs begin to hatch.

Ornamental Plants (Indoor and Outdoor): To control sucking and chewing insects such as aphids and mealybugs, apply when insects appear. Repeat as necessary. For indoor use: cover the aquarium as Rotenone is highly toxic to fish. For outdoor use: do not use Rotenone near the fish pond.

PRECAUTIONS: KEEP OUT OF THE REACH OF CHILDREN. Do not contaminate feed or food. This product is toxic to fish and swine. Keep out of body of water. Do not reuse empty container. Wash hands after handling.

DISPOSAL: Rinse container and dispose of in household garbage. Do not reuse empty container.

FIRST AID: If ingested, swallow activated charcoal and/or induce vomiting with a finger at the back of the throat. If in eyes, wash with running water for 15 minutes and call physician. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention
