DIRECTIONS: Shake before use. Use aerosol inverted.

INDOOR USE: SPOT OR CRACK AND CREVICE TREATMENT TO CONTROL:
ANTS COCKROACHES, CRICKETS, SILVERFISH, SPIDERS, SAW-TOOTHED
GRAIN BEETLES (exposed stage): Spray into cracks, crevices,
around baseboards, and other places where these insects can hide.
Apply behind and beneath cabinets, refrigerators, sinks, stoves,
and in and around waste containers. For ants spray trails and
places where ants enter premises. Repeat as needed. Do not
contaminate foodstuffs or spray house-plants. Remove pets and
cover fish bowls before spraying. Do not allow children to
contact treated surfaces until surfaces are completely dry. Do
not apply as a space spray or to edible areas of food plants.

BROWN DOG TICKS: Do not spray animals. Spray sleeping quarters of pets, around baseboards, window and door frames, wall cracks and other areas of floors. Repeat as needed. Fresh bedding should be placed in animal quarters after spraying.

OUTDOOR USE: SPOT TREATMENT TO CONTROL ANTS, CLOVERMITES, CRICKETS, EARWIGS, FLEAS, FLIES, GNATS, HORNETS, MILLIPEDES, MOSQUITOES, SOWBUGS, BROWN DOG TICKS AND WASPS: Spray infested areas thoroughly, including outside surfaces of screens, doors, window frames, foundations, patios, or other places where insects may enter. For ants, spray hills and runways. For control of wasps and hornets, spray nests at night. Repeat as necessary. Do not spray vegetation. In addition to rapid initial kill, Residual Spray stays on treated surfaces and kills insects many weeks after the spray deposit has dried.

FIRST AID: Contains petroleum distillates. If swallowed, DO NOT INDUCE VOMITING. Obtain medical attention immediately. In case of poisoning, call a physician immediately.
