This insecticide is designed for use in automatic dispensers and releases a metered dose of 55 mg of insecticide every 15 minute intervals for the control of flies, mosquitoes, gnats, and drosophila. In restaurants, food processing plants, meat processing plants, hospitals, ski lodges, summer lodges, resorts, dairies, stables, cow barns, poultry houses with at least 170 cu. m of freeflow air space where these flying insects are and annoyance.

DIRECTIONS: Each dispenser is designed to protect an area up to

170 cu. meters for up to 30 days. Remove protective cap from the top of can and carefully can in the automatic dispenser. Suspend dispenser 2 metres above floor at point where air circulation will carry particles through the area.

CAUTION:

In meat and food processing plants, only apply when plant is not in operation. No exposed food products, ingredients, or packaging materials to be left in the room. Cover food handling equipment. Any treated surfaces that may contact meat food products or other food products should be washed and rinsed thoroughly with potable water after application and before re-use for food processing.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Contents under pressure: Container may explode if heated. Do not expose to temperatures above 50 'C. Do not puncture or incinerate. Remove bird cages and cover fish bowls while areas are being treated. Do not contaminate food, feed, or water. Do not spray over milk or milking equipment. Do not use in nurseries or where infants, ill or aged persons are confined. Do not use close to polished, plastic or varnished surfaces. Dispose of empty container in accordance with provincial requirements.
