### **DIRECTIONS FOR USE**

FOR APPLICATION ONLY AS A CRACK AND CREVICE TREATMENT FOR COCKROACH ELIMINATION.

Before use place this jar in Hot Water for 15 minutes. This product would be ready to use.

Use a tool with a small flat blade, like a putty knife, to apply approximately 30g in areas of approximately 10 square meters. Apply paste liberally in heavily infested areas, and sparingly in lightly infested areas. For use in homes, non-food areas of restaurants and other food and feed handling establishments, motels, hotels, hospitals, offices, nursing homes, new construction, industrial plant, yachts, theatres, trains, boats, ships, libraries, military bases, zoos, and kennels.

Apply product only when food areas are not in operation. Cover or remove food commodities before treatment. Thoroughly clean all food contact areas with potable water after treatment and before replacement of food.

Apply the paste into the seams, under and behind refrigerators, stoves, dishwashers, sinks, dryers and tubs and washing machines, into openings around drains, electrical conduits, sewers, sewer pipes and manholes.
