- 4. Spread a suitable absorbent such as clay or other absorbent on the slurried liquid, and shovel the absorbed material into an open drum.
- 5. Repeat if necessary.
- 6. Flush area with water, while observing proper environmental precautions.
- 7. Seal drum and dispose of contaminated material in accordance

with municipal or provincial recommendations. See DISPOSAL section.

#### DISPOSAL:

- 1. Triple or pressure rinse the empty container. Add the rinsings to the spray mixture in the tank.
