## FIRST AID

### **PRECAUTIONS**

KEEP OUT OF REACH OF CHILDREN. Avoid breathing spray mist.

Avoid contact with skin. Harmful if swallowed. Not for indoor use. While spraying for flying insects outdoors, hold container 1 to 2 meters away from plants and shrubs. Direct spray to fill the air around these plants without heavily wetting the plant foliage. Avoid smoking while spraying. Cover or remove all food before spraying. Do not spray on food crops. Direct spray away from people or animals. Allow spray to disperse for several minutes before entering the treated area.

Contents under pressure. Do not puncture container or expose to temperatures above 49°C. Never throw container into fire or incinerator. Do not place in hot water or near radiators, stoves or other sources of heat. Protect from freezing.

### **DIRECTIONS FOR USE**

SHAKE WELL BEFORE USING. Point spray nozzle away from face and in the direction of the space to be treated. Press down valve button and allow spray to fill the air where flying pests linger. For larger areas, best results are obtained by spraying in the direction of a slight breeze that allows fog to drift to areas of infestation. Spray while moving away from treated areas. Allow spray to dissipate before occupying the treated area. Repeat as necessary. Spray outdoor areas of the yard, patio and campground when there is no breeze or spray in the direction of a slight breeze. Controls flies and mosquitoes up to 6 meters away, if contacted by spray using this fog nozzle.

FLYING INSECTS: Reduce annoyance from **flies, mosquitoes, and moths** by directing spray to contact insects from a distance of 1 to 2 meters from the flowering plants, shrubbery, and grass to where the insects may be resting. Avoid heavy wetting of plant foliage. Also spray around garbage cans and other breeding areas. Repeat as necessary. Spray directly on wasps and hornets. Thoroughly wet the nesting area during the evening when insects are least active.

CRAWLING INSECTS: Spray directly on ants, centipedes, sowbugs and spiders. Treat areas around garbage cans, picnic sites and campgrounds infested by these pests. Also thoroughly spray ant hills for best results. Spray, contacting as many insects as possible, in short bursts of 2 seconds at a 1 to 2 meters distance. Repeat applications as necessary.

### **STORAGE & DISPOSAL**

Do not use or store near heat or open flame. Flashpoint minimum 38°C (100°F).

**DISPOSAL:** When container is empty, press valve to release remaining pressure. Wrap and dispose of used container with household garbage.
