When allowed to dry without rinsing, continues to exert antimicrobial action for as long as 7 days.

Cleans: N-L 500 is a full-range cleaner, based on synthetic detergents. It easily removes heavy soil, does not leave an undesirable film, and does not require rinsing.

Deodorizes: N-L 500 is effective as a deodorant because it penetrates and emulsifies odorous organic matter and destroys odour-producing bacteria.

Directions: For disinfecting (including premises occupied by tubercular patients) and cleaning, use 1 part N-L 500 to 80 parts (12 mL per litre) water. Damp mopping - 6 mL per litre.

"Allow surface to remain wet for 10 minutes, then remove excess liquid. Prepare a fresh solution for each use."

Areas of use: Hospitals, nursing homes, schools, offices, shopping malls, supermarkets, apartment complexes, etc.
