General Information: Sprayco is a combination of a light mineral oil and a superior type of surface acting agent (Surfactant) specially formulated to form a super emulsifiable oil. It is to be used in combination with Atrazine or Dinoseb to improve the activity of these products.

Directions: The herbicide should be added to the water before adding Surfactant. Agitate the mixture during the filling operation and when applying to crop. Do not leave the mixture over a long period of time without agitation.

WEED CONTROL IN CORN: SEEDLING WEEDS AND ANNUAL GRASSES: To increase the activity and extend the period of application of Atrazine, apply 1.1 - 2.25 kg per hectare of Atrazine combined

with 2.75 - 5.5 litres of Sprayco (Surfactant) Oil Concentrate in 150 - 300 litres of water per hectare. Under most conditions 1.25% Sprayco in the mixture is sufficient. For very heavy weed pressure or weeds in an advanced stage, 2% Sprayco (4 litres in 200 litres of water) may improve control. Apply to broadleaf weeds in the 2 - 4 leaf stage and grasses in the 2 - 3 leaf stage (5 cm in height) for best results.

Note: Corn should not be taller than 15 cm when spray application is made (5 leaf stage). Do not add any other herbicides.

POTATO-VINE KILLING: TOTAL VEGETATION CONTROL: Apply Dinoseb according to label instructions plus 2.75 - 5.5 litres of Sprayco in 200 - 300 litres of water per hectare. Apply mixture overall broadcast at least ten days before harvesting. Use the higher rates of materials in cool, cloudy weather or when total vegetation is dense. Do not spray exposed tubers or graze treated fields.
