Apply with a mist fogger (non-thermal) or manual pump at a rate of 200 mL/100m3. Apply to cracks, crevices and wall surfaces. Direct spray, upwards, towards ceilings and walls or straight on insects. Keep area closed for 10-20 minutes after fogging. Ventilate thoroughly before reentering treated areas. Repeat as necessary. Do not use in rooms where milk is processed, handled or stored.

When using a mist fogger, the equipment must be maintained and operated in accordance with the manufacturer's instruction manual.

NOTE: Treatment should be made before or after milking only.
